**A BYLAW OF THE CITY OF MELFORT TO AMEND BYLAW NO.
96-09 KNOWN AS THE CITY OF MELFORT ZONING BYLAW**

The Council of the City of Melfort in the Province of Saskatchewan in open meeting hereby amends Zoning Bylaw No. 96-09, in the manner hereinafter set forth:

1. That the Zoning District Map forming part of Bylaw 96-09 be amended as follows:
 - a) by rezoning Lots 29 - 31, Blk/Par 38, Plan 102119947, from R3 – Multiple Unit Residential, to R2 – Medium Density Residential,

as shown on the attached Schedule “A”.

2. This Bylaw shall come into force and take effect upon final passing.

READ A SECOND TIME this 13th day of November, 2017.

READ A THIRD TIME and passed this 13th day of November, 2017.

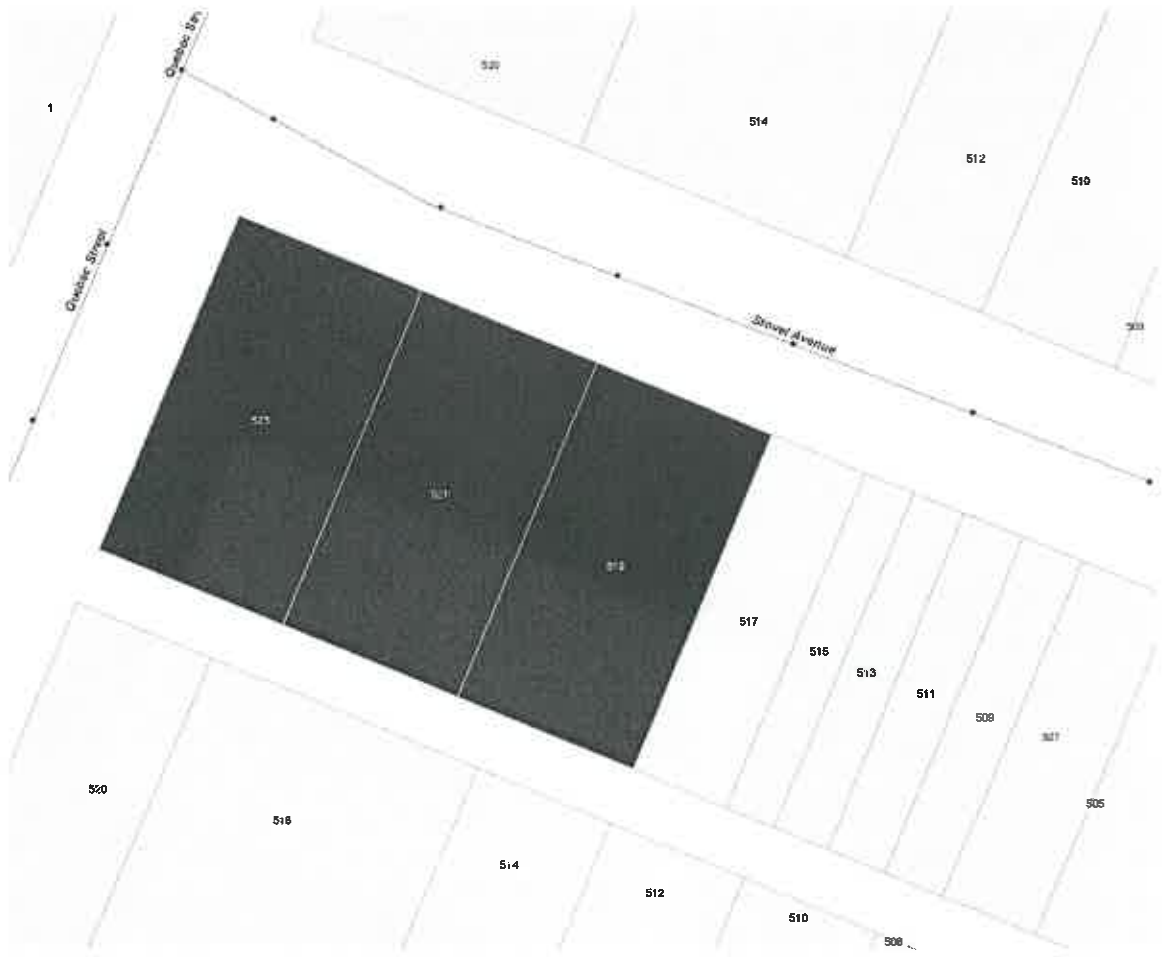

Lots 29 – 31, Blk/Par 38, Plan 102119947



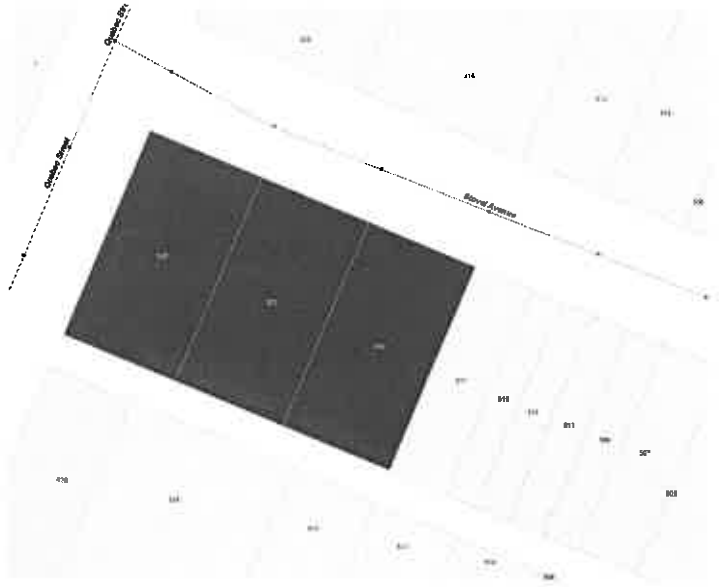
